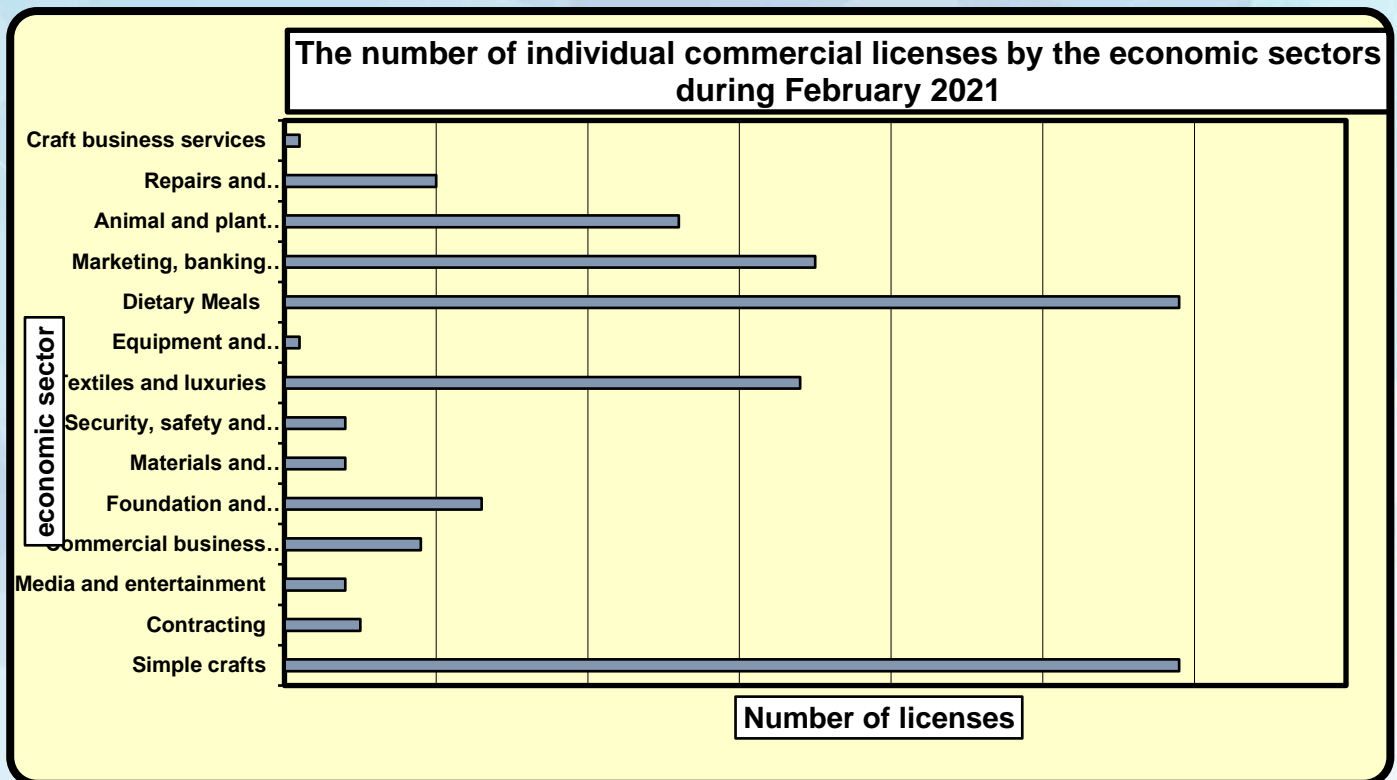
First: Individual commercial licenses sector:

The volume of licenses issued according to the economic sector: .1

The number of individual commercial licenses that the Ministry agreed to issue during February 2021 reached (264) licenses in various economic activities, of which (59) licenses in the simple crafts sector (59), licenses in the marketing, banking and hotels sector, (35) licenses in the textile sector. And luxuries, (34) licenses in the animal and plant products sector (26) licenses in the animal and plant products sector.

2. The volume of licenses issued according to activities:

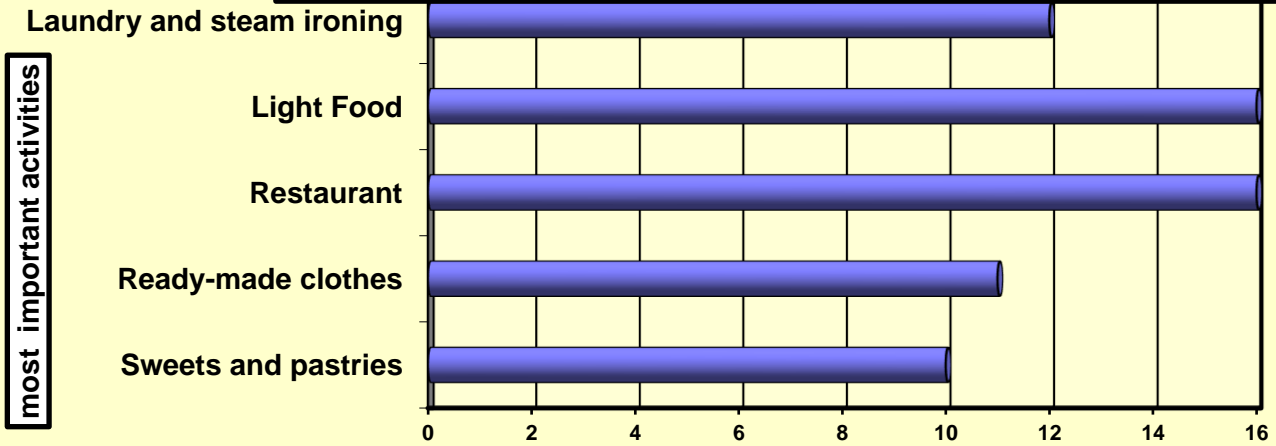
The (264) licenses were classified during the month into several economic activities reaching to (5) classification, in addition to other activities that could not be classified due to their small size and large number.

Most notably, the activity (restaurant, snacks) was about 6% of the total licenses, followed by the following activities (Laundry and steam ironing) at 5%, followed by other activities (ready-made clothes, sweets and pastries) at a rate of about 4% of the total licenses, The rest of the licenses for other activities, excused to be classified, accounted for 75% of the total licenses.

3. The volume of licenses for companies of persons issued according to activities:

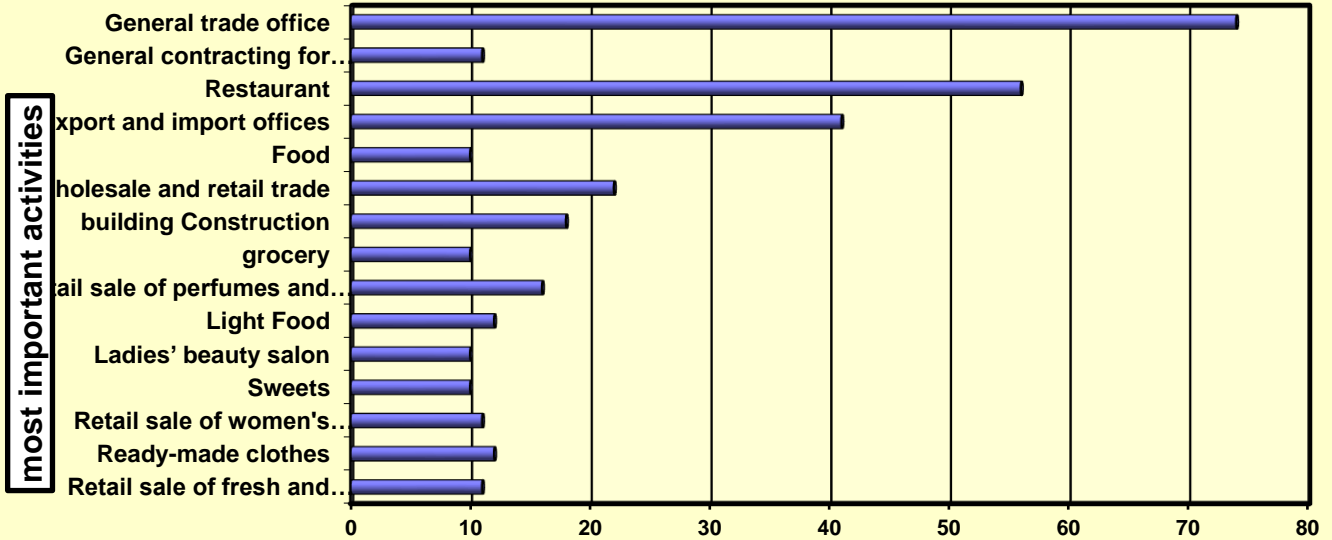
The (831) licenses were classified during the month into many economic activities amounting to (15) classifications, in addition to other activities that could not be classified due to their small size and abundance.

Most notably, the activity (general trade office) was estimated at about 9% of the total licenses, followed by the activity (restaurant) at an estimated rate of 7%, followed by the activity (export and import offices) at a rate of about 5% of the total licenses, followed by the activity (wholesale and retail trade) With an estimated rate of about 3%, followed by the activity (building construction, retailing of perfumes and cosmetics) at a rate of about 2%, followed by the following activities (snacks, ready-made clothes, general contracting for buildings, retail of women's ready-to-wear clothes, retailing of fresh and preserved fruits and vegetables. , Groceries, foodstuffs, sweets, ladies' beauty salon) at a rate of about 1% for each activity from the above, and the rest of the licenses for other activities excluding their classification amounted to 61% of the total licenses.

number of licenses for partnership companies for the most important activities of February 2021



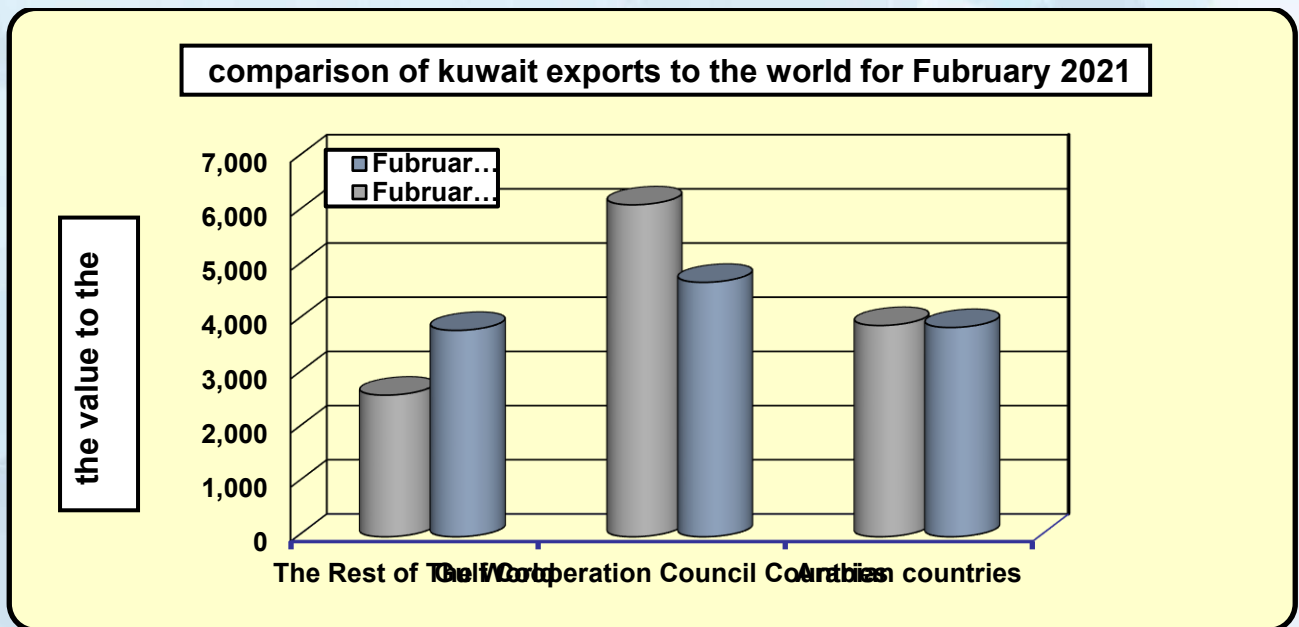
Kuwaiti exports

The total exports of Kuwaiti origin during February 2021 amounted to about 12 million KWDs distributed to the Gulf Cooperation Council countries, Arab countries, and the rest of the world. The share of exports to Arab countries was about 4 million KWDs, achieving a percentage estimated at about 31%. The rest of the world countries are about 31%, with exports estimated at about 4 million Kuwaiti dinars, and the value of exports to the Gulf Cooperation Council countries is about 5 million, with an estimated rate of 38% of the total exports. It is noted that there has been a decrease in the value of total exports relative to last month's exports, which amounted to 6%. As for comparison with the same month of last year, there has been a decrease in the month's exports estimated at about 2%.

First: Kuwaiti exports of origin for the Al Arabiya Group:

Egypt was at the forefront of these countries, with exports estimated at about 1 million Kuwaiti dinars, at a rate of about 27% of the total exports to Arab countries, followed by exports to Jordan, achieving about 26%, as its total exports were estimated at about one million Kuwaiti dinars. Iraq comes in third place, where it achieved an estimated rate of about 25%, and the value of its exports amounted to about 971 thousand Kuwaiti dinars, and in fourth place Palestine, where the value of its exports amounted to about 317 thousand Kuwaiti dinars, an estimated rate of 8%. Distributed in Lebanon, Yemen, Morocco, Tunisia, Sudan, Algeria, and Syria.

It is noticeable that the exports of this month to the Arab countries decreased in relation to last month's exports, which is estimated at about 12%, and there has been no significant change for the same month of last year.

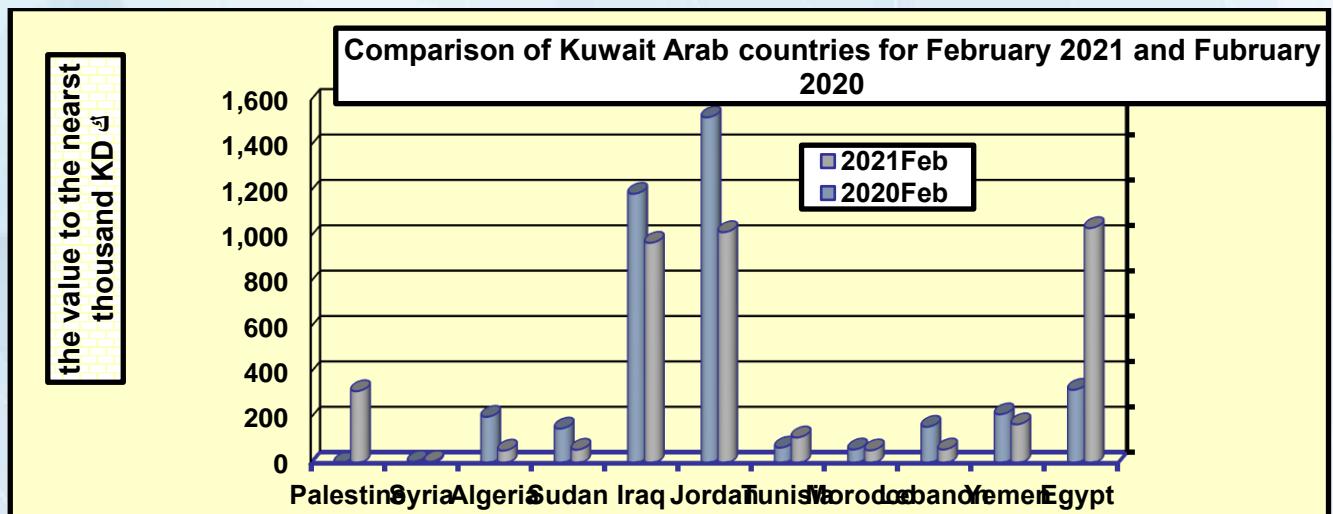

Second: Kuwaiti origin exports to other countries of the world:

As for exports to other countries of the world, Belgium occupied the forefront of the world's exporting countries, where the value of its exports amounted to about 927 thousand dinars, an estimated rate of about 24% of the total exports to other countries of the world, and Italy ranked second with exports estimated at about 825 thousand KWDs, with an estimated rate of about 22% of the total exports, and Portugal ranked third, as its total exports amounted to about 767 thousand Kuwaiti dinars, an estimated rate of about 20% of the total exports to the countries of the world. As for the rest of the exports of other world countries during this month, they were distributed among Turkey, Spain, France, Poland, Cyprus, Slovenia, Bulgaria, Guyana, Peru, Brazil, Greece, Luxembourg, Colombia, Liberia, Venezuela, Mexico, Australia, America, Benin, Ukraine, Singapore, India, Sweden, Sri Lanka, Britain, and Bangladesh.

It is noticeable that the exports of the rest of the other countries of the world increased during this month relative to the previous month, by an estimated 46%, while there was a significant increase in the exports of the month to the rest of the other countries in relation to the exports of the same month of last year, estimated at about 40%.

Third: Kuwait originating exports to the countries of the Gulf Cooperation Council:

As for exports to the countries of the Gulf Cooperation Council, the State of Qatar ranked first among the Gulf countries to export to, as the value of its exports amounted to about 3 million Kuwaiti dinars, an estimated rate of about 64% of the total exports, and the Kingdom of Saudi Arabia ranked second with exports estimated at about 839 thousand Kuwaiti dinars. With an estimated rate of about 18% of total exports, and the United Arab Emirates ranked third, as its total exports amounted to about 596 thousand Kuwaiti dinars, an estimated 13% of the total exports to the Gulf countries From the Sultanate of Oman and the Kingdom of Bahrain.

It is noticeable that the exports of the Gulf Cooperation Council countries decreased during this month relative to the previous month by an estimated 22%, while there was a decrease in the exports of the month of the Gulf Cooperation Council countries in relation to the exports of the same month last year, estimated at about 23%.

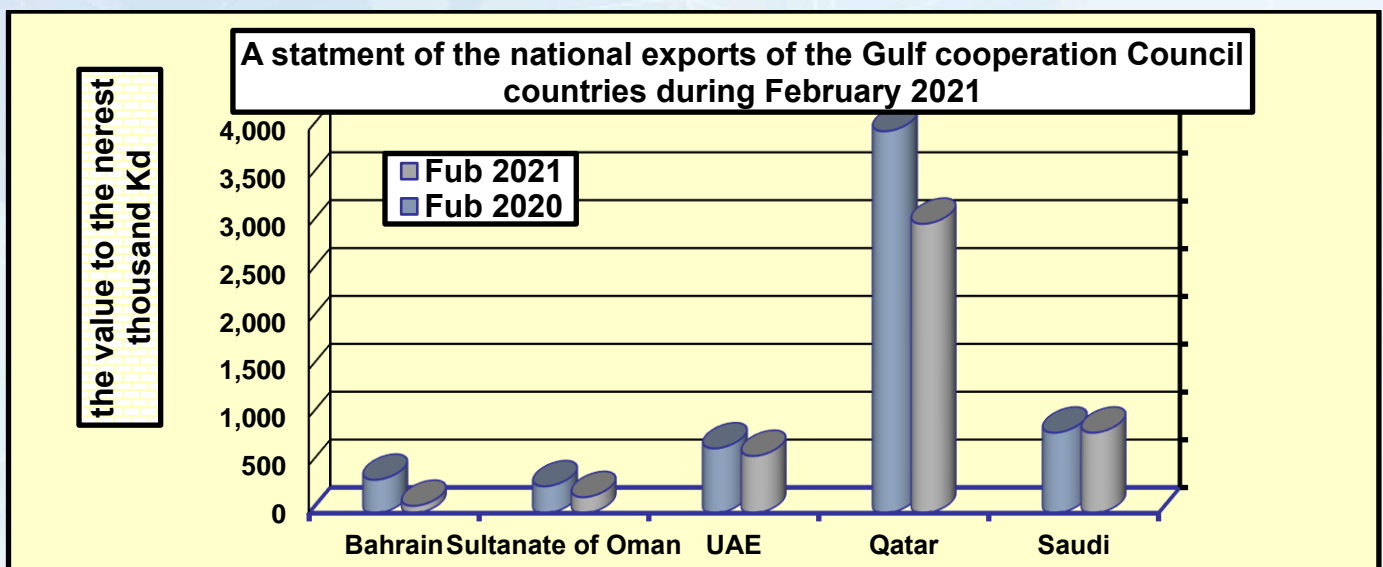

Valuables Metals

The ministry stamped about 2.4 tons of gold during February 2021, compared to about 1.4 tons in February 2020.

There was also a noticeable decrease in the quantities of silver that were stamped during this month compared to February 2020, as it reached about 39 kg during the month after it recorded about 117 kg during February of last year.

There has also been a decrease in the quantities of valuable stones that were examined and evaluated by the Ministry, which was estimated at about 28% compared to last February, as the quantities of stones reached 60 pieces during the current month, compared to 83 pieces during last February.

The quantity of gold and silver bars reached 3,016 tons during this month, compared to 551 kg in February 2020, an increase of 447%.

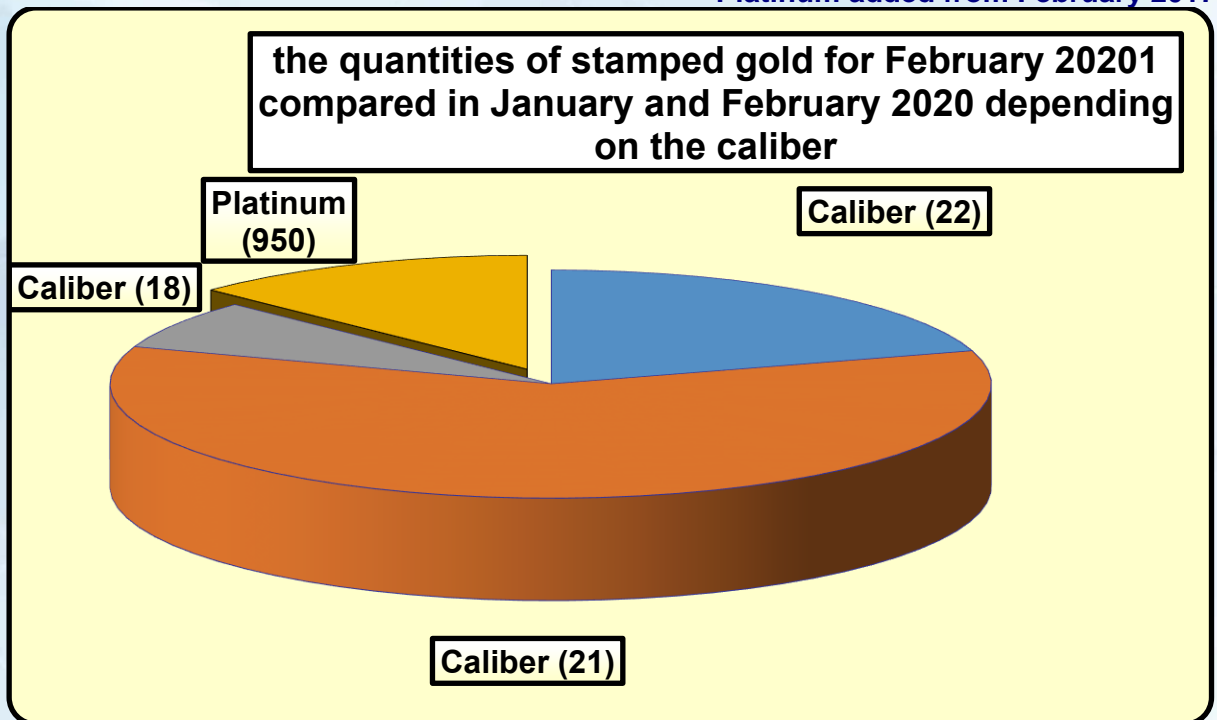

Support

- During the month of February 2021, the Ministry provided support for many materials estimated at approximately 10 million Kuwaiti dinars 9,510,880, and thus its subsidy decreased by an estimated 34% compared to last month.

- The group of basic materials that are disbursed through the Support card for this month received an estimated support of about 4 million Kuwaiti dinars, and its percentage is about 37% of the total support referred to above, and this group includes regular powdered milk, vegetable oil, tomato paste, chicken. Its subsidy has decreased by an estimated 60% compared to last January, but if the support for infant formula and feeders is added to this group at an estimated rate of about 3% of the total support, thus the total support for the flour milling company will be about 41% of the total support spent during February 2021.

The value of the previous materials subsidy was disbursed to the Kuwait Catering Company, which was estimated to total approximately 4 million Kuwaiti dinars. Its subsidies decreased by an estimated 58% from what was disbursed last month

The cement subsidy for the Kuwait Catering Company and Kuwait Cement Company has reached about 484 thousand dinars, at an estimated rate of about 5% of the total subsidy, and an increase in subsidies has been observed, by an estimated 26% compared to last month.

- The iron subsidy provided by the ministry during the month amounted to about 2 million KWD, which represents an estimated 18% of the month's subsidy, and an increase of about 14% compared to last month is noted.

- The white insulating bricks subsidy during this month amounted to 287 thousand dinars, an estimated rate of about 3% of the total subsidy for the month, and compared to last month, an increase of about 2% is noticed.

- Air conditioning support amounted to about 840 thousand Kuwaiti dinars, an estimated rate of about 9% of the total support, and a decrease of about 4% compared to last month is noticeable.

- The concrete subsidy amounted to about KD 1.5 million, an estimated rate of about 15% of the total support, and an increase of about 25% compared to the previous month.

- As for cement bricks, its subsidy amounted to about 319 thousand dinars, or 3% of the total subsidy for the month, and it is noticeable that there is an estimated decrease of about 11% compared to last month

- The support for health teams amounted to about 109 thousand Kuwaiti dinars, with an estimated rate of about 1% of the total support spent, and an increase of about 40% compared to last month

- As for electrical wires, their subsidies amounted to about 276 thousand Kuwaiti dinars, at a rate of 2% of the monthly subsidy, and it is noticeable that there has been a decrease of about 12% compared to the previous month.

- The ceramic and porcelain subsidy amounted to about 15 thousand Kuwaiti dinars, with a negligible percentage of the total subsidy for the month. It is noticeable that there has been a remarkable increase of about 373% compared to last month.

- External cladding subsidies amounted to about KD 167 thousand, with an estimated rate of about 1% of the total subsidy for the month, and a decrease of about 4% compared to last month is noted.

About 284 thousand cement bags were disbursed to 166 beneficiaries, in addition to 6.4 thousand tons of iron to 147 beneficiaries, and the white insulating bricks were disbursed to 145 beneficiaries, and its quantity amounted to about 13 thousand square meters. One million bricks, and the disbursement of ready-mixed concrete to 144 beneficiaries, with a quantity of about 57,000 cubic meters, and these materials were during February 2021.

As for the number of beneficiaries in air conditioning, their number reached 115 beneficiaries, and the amount of 575 thousand Kuwaiti dinars was disbursed, and the number of beneficiaries of health kits reached 70, and an amount of about 22 thousand was disbursed to them. The number of ceramic and porcelain beneficiaries reached 1 beneficiaries, and about 2 were disbursed. As for the electrical wires, the number of beneficiaries was 34, and 51 thousand dinars were disbursed to them. As for the beneficiaries of coarse dyes, the number reached 13 beneficiaries, and 19 thousand dinars were disbursed to them, during February 2021.

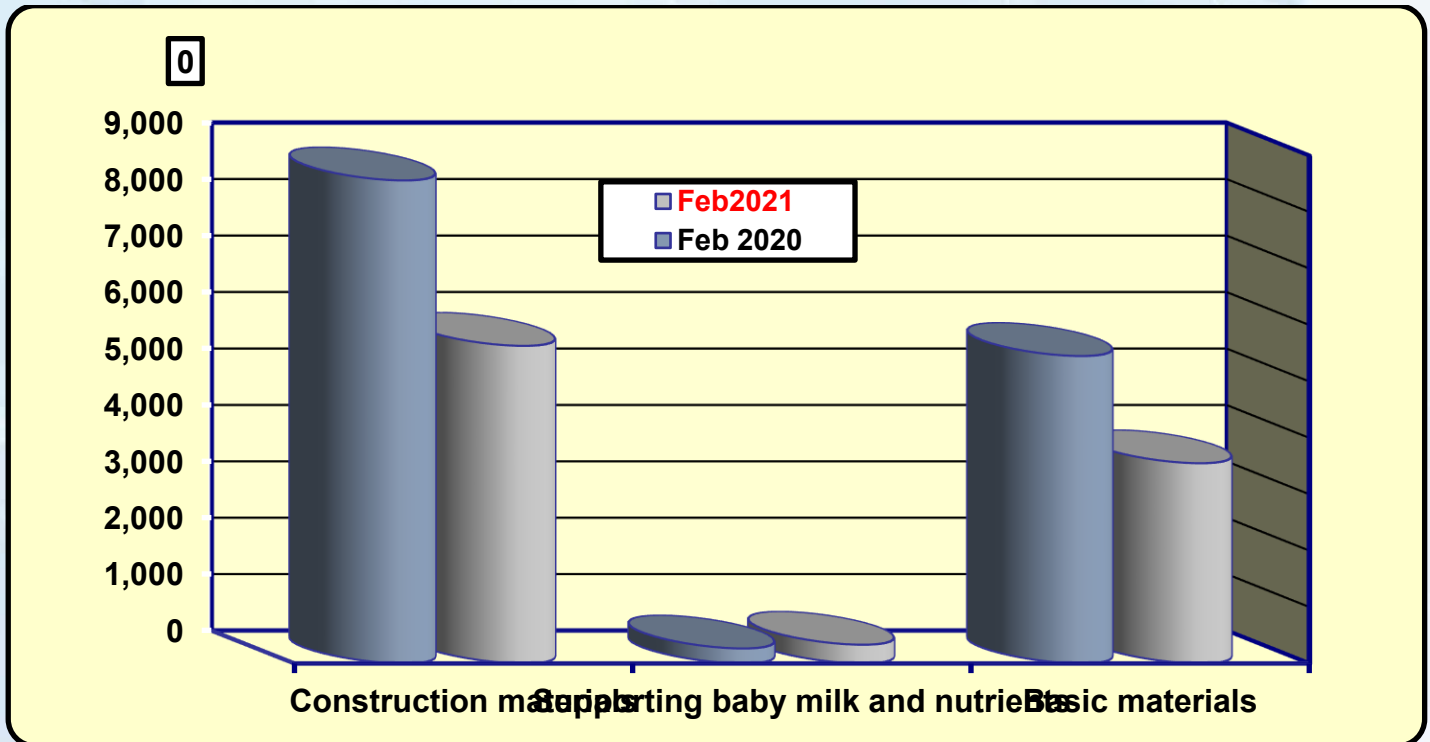

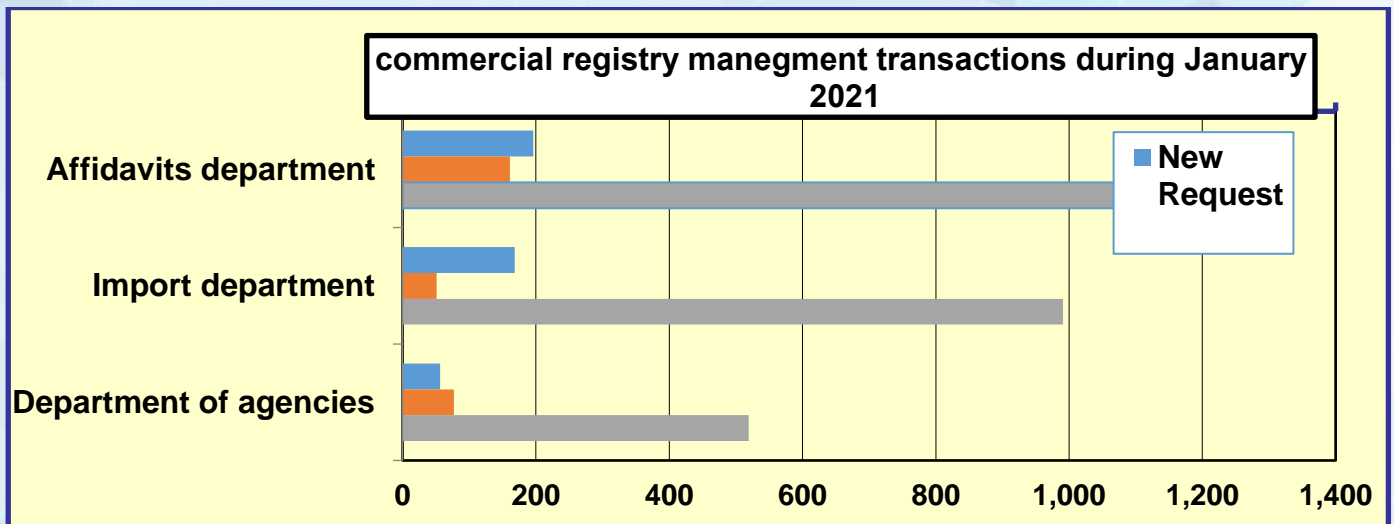

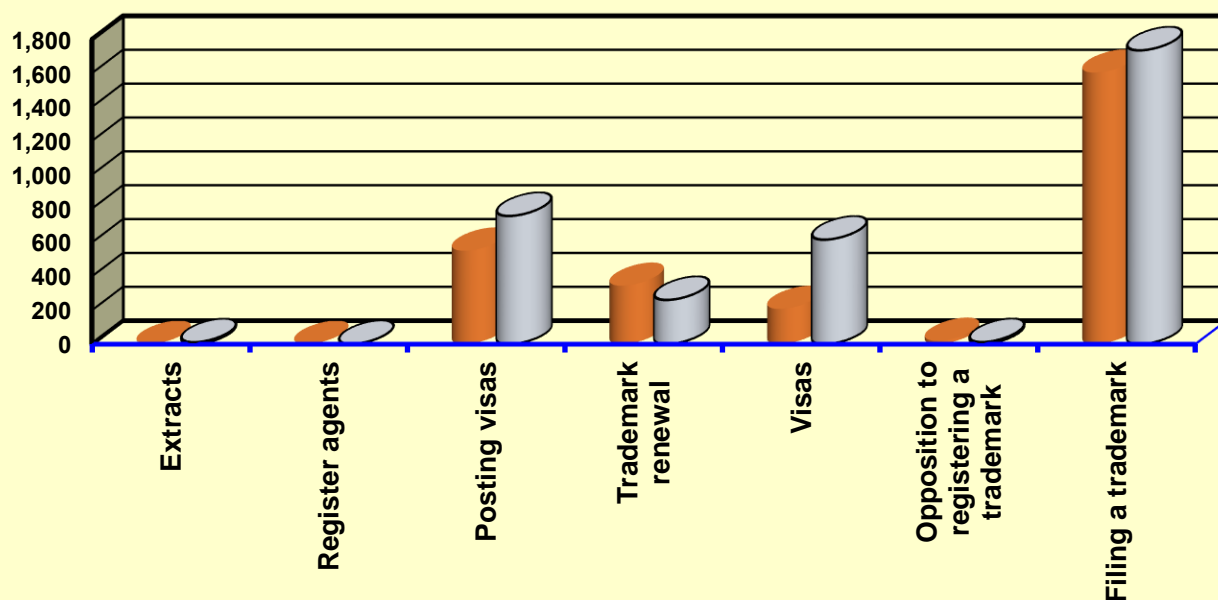
