
First:Individual commercial licenses sector: <u>1. Volume of Licenses Issued by Economic Sector:</u>

The number of individual commercial licenses that the Ministry agreed to issue during December 2020 reached (398) licenses in various economic activities, including (10) licenses in the simple crafts sector, (14) licenses in food sector, marketing, banking and hotels, (3) licenses in textiles and luxuries, (9) licenses in animal and plant products sector, and finally (7) licenses in business services sector.

2:Volume of licenses with respect to activities.


(398) licenses were classified during one month into several economic activities reaching (7) classifications, some other activities were not classified due to their small size and large number.

Most notably activity was (light food) at a rate estimated about 7% of the total licenses, followed by the activity of (restaurants) at a rate of 6% of the total licenses, followed by the activity of (Grocery, men's haircut) at a rate of 5% of the total licenses for each licenses, followed by the activity of (beauty ladies salon,)at a rate estimated about 4% of the total licenses for each activity, followed by activity women clothing tailor at at a rate of 3% of the total licenses, and the rest of the licenses for other activities are excused from classification were at rate of 67% from total licenses.



3. Volume of licenses for companies of persons issued by activities:

(1,563) licenses were classified during the month into many economic activities (26) activities, with some other activities that could not be classified due to their small size and large number.

Most notably, (general trade office) activity was about 16% of the total licenses, followed by (restaurant, general contracting for building) at a rate of about 7%,5% respectively of the total licenses, followed by the following activities (import and export, grocery, food supplies, ready-made clothes, Sweet and pastries, Ladies' beauty salon, Food supplies, light food) at a rate of about 2% for each activity from the above, and the rest of the licenses for other activities were not classified and they present 42% of the total licenses.



Kuwaiti exports

Total exports of Kuwait origin during December 2020 amounted about 11 million KD, and they were distributed on Gulf countries, Arab countries, and the rest of World. Arabic countries achieved the value of 4 million KD achieving percentage estimated about 42%. The percentage of the rest of the world reached about 13% achieving exports value estimated at about 1 million KD. The value of exports to the Gulf Cooperation Council countries were estimated about 5 million KD and it present 45% of the total exports. It is noted that there has been a decrease in the value of total exports relative to last month's exports, which amounted to 27%. Comparing with the same month of last year, there has been a decrease in the export percentage estimated about 40%

First: Exports of Kuwait origin to Al Arabiya Group:

Iraq occupied the forefront of these countries, with exports estimated about 2 million KD, at an estimated rate of about 50% of the total exports to Arab countries, followed by exports to Jordan, achieving about 24%, as the total exports were estimated about 277 thousand KD, followed by the third place, Yemen, where it achieved a rate of about 6%, and the value of the exports amounted to about 277 thousand KD. The fourth place was for Algeria, where the value of the exports amounted to about 271 thousand KD, with an estimated rate of about 6%, and as for the rest of the exports for this month, they were distributed all over Lebanon, Egypt, Syria, Morocco, Palestine, Libya, Sudan, and Tunisia. It is noticeable that the exports of this month increased to Arab countries in relation to last month's exports, which are estimated at about 23%. There has also been a slight decrease in the month's exports to Arab countries compared to the exports of the same month of last year, at a rate estimated about 21%.



Second: Kuwaiti origin exports to other countries of the world:

As for exports to other countries of the world, Belgium occupied the forefront of the world's exporting countries, achieving the value of exports amounted to about 491 thousand KD, with an estimation of 33% of the total exports to other world countries, turkey ranked second with exports estimated about 326 thousand KD, with an estimated rate of about 22% of total exports, and the third place was for Italy, achieving the total exports amounted to about 160 thousand KD with an estimation of about 11% of the total exports to the world countries. As for the rest of the exports of other world countries during this month, they were distributed among all France, India, Spain, Colombia, canada, America, Chilean, Britain, Portugal, Peru, Slovenia, Korea, Mozambique, and Leetonia. It is noticeable that the exports of the rest of the other countries of the world decrease during this month relative to the last month, by an estimated 53%, while there was a clear decrease in exports for the rest of the other countries in relation to exports of the same month last year, estimated about 62%



Third: Kuwait origin exports to Gulf Countries:

As for exports to the countries of the Gulf Cooperation Council, United Arab Emirates occupied the forefront of the exporting Gulf countries, as the value of their exports amounted to about 2 million KD, with an estimation rate of about 33% of the total exports, and Qatar ranked second with exports estimated at about 2 million KD by an estimation of 30% of the total exports. State of Qatar ranked third, as its total exports amounted to about 1 million KD with an estimation of 22% of the total exports to the Gulf cooperation council countries. As for the rest of the exports during this month, they were distributed to each of Bahrain and the Sultanate of Oman. It is noticeable that the exports of the Gulf Cooperation Council countries decrease during this month compared to the previous month, by 39%, while there was an decrease in the month's exports to the Gulf Cooperation Council countries in relation to the same exports of month in last year with an estimation of 43%.



Precious metals

The ministry stamped about 2 tons of gold during December 2020, compared to about 2 tons in December 2019. There was a decrease in the quantities of silver that were stamped during this month compared to November 2019, as it reached about 61 kg during this month, after recording about 467 kg during December of last year.

There has been a Increase also in the quantities of valuable stones that were examined and evaluated by the ministry, which was estimated about 25% compared to last December, as the quantities of stones reached 96 pieces during the current month, compared to 77 pieces during last December.

The quantity of gold and silver bars reached 1,350 tons during this month, compared to 932,967 kg in December 2019, an increase of 45%.



Giving Support

- The Ministry provided within December 2020 support for many of materials, in amount of about 12 million Kuwaiti Dinar (12,015.848 KD), so its support has been decreased in rate about 3% from last month.
- The basic materials set which are provided with the rationing cards for this month got about 6.9 million KD, in percentage of 58% of the aforementioned support, this set contains Beshawer rice, sugar, ordinary powdered milk, vegetable oil, tomato paste, chickens, lentils and flour.
- It is noticeable that; its support has been decreased in percentage of 13% in comparing of last November, but if we add to this set the support of the infant's milk and feeders with percentage of 3% of the total support, so the gross total support for Flour Mills Company is about 61% of the total support provided within December 2020.
- Also, the previous support amount has been given to the Kuwaiti companies for ration, which total amount was about 7 million KD, its support has been decreased with percentage of 13% from what was given within last month.
- The cement support amount for Kuwait Flour Mills and Bakeries Company and Kuwait Cement Company reached about 461 thousand KD, with percentage of about 4% of the total support, it is noticeable that; its support has been decreased with percentage of about 21% from last month.
- The iron support amount which was provided by the Ministry within the month was about 1,03 million KD, which represents about 11% of the month support, it is noticeable that; an increasing with percentage of about 21% was happened in comparing of the last month.
- The support of the isolating white bricks within this month reached about 252 thousand KD, with percentage of 2% of the total support of the month and there aren't any changes comparing of the last month.
- The conditioning support reached about 572 thousand KD, with percentage of 5% of the total support of the month; it is noticeable that; an increasing with percentage of about 12% was happened in comparing of the last month.
- Concrete support reached about 1.2 million KD, with percentage of 10% of the total support of the month it is noticeable that an increasing with percentage of about 68% was happened in comparing of the last month.
- The cementic bricks support reached about 273 thousand KD, with percentage of 2% of the total support of the month; it is noticeable that; a decrease with percentage of about 9% was happened in comparing of the last month.
- Sanitary ware sets support reached about 81 thousand KD, with percentage of 1% of the total support of the month; it is noticeable that; a decrease with percentage of about 4% was happened in comparing of the last month.
- The electrical wires support reached about 321 thousand KD, with percentage of 3% of the total support of the month; it is noticeable that; an increasing with percentage of about 5% was happened in comparing of the last month.
- Ceramic and porcelain support reached about 3 thousand KD, with a negligible percentage of the total support of the month; it is noticeable that; a decrease with percentage of about 88% was happened in comparing of the last month.
- The external cladding support reached about 235 thousand KD, with a negligible percentage of the total support of the month; it is noticeable that; a decrease with percentage of about 7% was happened in comparing of the last month.



- The waterproofing support reached about 1.5 thousand KD, with a negligible percentage of the total support of the month.
- It was provided about 442 thousand cement sacks for 263 beneficiaries, 10 thousand tons of iron for 227 beneficiaries, about 19 thousand cubic meters of the isolating white bricks have been provided for 226 beneficiaries, 3 million bricks of the cementic bricks have been provided for 228 beneficiaries, 3 million cubic meters of the ready concrete have been provided for 224 beneficiaries, all of these materials have been provided within November 2020.
- For the number of beneficiaries by conditioning, they reached 188 beneficiaries, an amount of 940 thousand KD has been provided for them, the number of beneficiaries by sanitary ware sets, they reached 432 beneficiaries, an amount of 129 thousand KD has been provided for them, the number of beneficiaries by ceramic and porcelain, they reached 11 beneficiaries, an amount of 17 thousand KD has been provided for them, the number of beneficiaries, they reached 255 beneficiaries, an amount of 379 thousand KD has been provided for them, the number of beneficiaries, an amount of 229 thousand KD has been provided for them provided for them, they reached 155 beneficiaries, an amount of 229 thousand KD has been provided for them within November 2020.




